

The grassed area will be replaced with species rich turf, enhancing biodiversity, improving soil health and reducing maintenance needs.

Wildflower turf is then proposed around the perimeter of the garden, it's perennial flowers will attract pollinators and other insects to the green space.

Existing dense shrub planting will be reinforced with additional, largely native shrubs, providing a greater barrier between houses which back onto the green space.

Open space offers opportunities for residents to creatively use the space, for a picnic on the grass or a badminton net.

A limited area of resin bound gravel will allow the space to be useable all year round and accessible for all. Resin bound is permeable, meaning it allows for natural filtering of water back into the ground.



WILDFLOWER MEADOW PLANTING & SURFACING PRECEDENTS



In addition to planting, other interventions to encourage wildlife across the site include bee posts, habitat hotels and bird boxes. An information board of wildflower species, alongside a magnifying glass, would also help teach plant identification and inspire engagement with the wildlife.



A mixture of formal and informal seating would be dispersed within the Wildflower Meadow, located toward areas set back from residential gardens and toward public circulation areas within the estate.

A bin would also be located to discourage littering.
