

ENFORCEMENT NOTICE TO TAKE SPECIFIED STEPS IN RELATION TO A BREACH OF PERMIT CONDITIONS

To: Seletia (F) Limited 10 James Nasmyth Way Eccles Manchester M30 0SF

Environmental permit: EPR/BM5941IH

Regulated facility: Flusco Landfill, Newbiggin, Penrith, Cumbria. CA11 0JB

The Environment Agency considers that the following conditions of the environmental permit are being contravened:

- 2.1.1 Permitted activities
- 2.5.3 Landfill engineering New cell construction proposals changes
- 2.9.1 Landfill gas management
- 3.1.2 Emissions to water
- 3.5.1(c)&(e) Groundwater and surface water monitoring

Because there is an unauthorised activity taking place on site involving deposit, transfer and storage of waste on the transfer pad; engineering work to the access roads and within the base of the quarry has taken place without the required approvals; landfill gas is not being managed appropriately; contaminated liquid is discharging from an unauthorised emission point; and the required groundwater and surface monitoring is not possible due to infrastructure damage.

You are required to take the steps set out in Schedule 1 by the dates specified in order to remedy the contravention.

General

- 1. Failure to comply with this notice is an offence under Regulation 38(3) of the Environmental Permitting (England and Wales) Regulations 2016 and may result in legal action being taken against you.
- 2. Without prejudice to the requirements of this notice, failure to comply with a condition of an environmental permit is an offence and may result in legal action being taken against you.
- 3. You may wish to seek independent legal advice.

Appeal provisions

You are entitled to appeal against this notice under Regulation 31(1)(f) of the Environmental Permitting (England and Wales) Regulations 2016. Notice of appeal must be made within two months of the date of this notice. An appeal does not affect the requirements of this notice.

At the same time, you must send a copy of the appeal notice and documents to us.

The required documents are:

- a statement of the grounds of appeal;

- a copy of any decision or notice which is the subject matter of the appeal; and
- a statement indicating whether you wish the appeal to be in the form of a hearing or dealt with by way of written representations.

You may withdraw an appeal by notifying the Secretary of State in writing and sending a copy of that notification to us.
