**ROAD TRAFFIC REGULATION ACT 1984**

THE KENT COUNTY COUNCIL, acting as Local Traffic Authority and in exercise of its powers under Sections 81, 82, 83 and 84 of the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act') as amended, and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby intends to make the following Order.

**REVOCATION, MODIFICATION AND AMENDMENTS**

The "Kent County Council (Various Roads, The District of Canterbury) (20mph, 30mph, 40mph, 50mph Speed Limits and Derestricted Roads) Consolidation Order 2012" ("the Order of 2012") be amended as follows.

In Schedule 5 of the Order of 2012 the following entry in the Table below shall be deleted from the Schedule.

<b>Item No</b>	<b>Road Name</b>	<b>Parish</b>	<b>Description</b>
13	STONE STREET	PETHAM	From a point 160 metres south of its junction with Lime Kiln Lane to a point 355 metres north of its junction with Chequers Hill.

Notice is hereby given that KENT COUNTY COUNCIL propose to make the above named Order under sections under Sections 81, 82, 83 and 84 of the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Schedule 9 to the Act:

The effect of the Order will be to reduce the existing 50mph speed limit to 40mph on the following length of roads in Petham, Canterbury:

**STONE STREET** - From a point 193 metres south of its junction with Hogg Lane to a point 355 metres north of its junction with Cheques Hill.
