BYELAWS

made by the Mayor, Aldermen and Burgesses of the Borough of Wallasey, acting by the Council under the powers conferred by the Public Health Act, 1875, and the Public Health Acts Amendment Act, 1907, with respect to the Promenades within the said Borough.

Interpretation.

- 1. In these Byelaws unless the context otherwise requires, the following words and expressions have the meaning hereinafter respectively assigned to them, namely:—
 - "The Borough" means the County Borough of Wallasey.
 - "The Corporation" means the Mayor, Aldermen and Burgesses of the Borough of Wallasey, acting by the Council
 - "The Commissioners" mean the Wallasey Embankment Commissioners.
 - "The Promenades" mean the whole or any part of the footways, carriageways, and public gardens of the following places of public resort, viz.:—
 - (a) The "Seacombe Promenade".
 - (b) The "Sandon Promenade".
 - (c) The "Egremont Promenade".
 - (d) The "Magazines Promenade".
 - (e) The "Tower Promenade".
 - (f) The "Marine Promenade".
 - (g) The new Promenade constructed by the Corporation and known or intended to be known as "The King's Parade" commencing at the termination of the Marine Promenade and extending thence in a Westerly direction to the Red Noses.

- (h) The Sea Defence Works extending from a point 950 yards east of Harrison Drive in a Westerly direction for a distance of 3,150 yards to a point 800 yards west of the public footpath crossing the Wallasey Golf Links.
- (i) The Wallasey Embankment extending from Leasowe Golf Links Club House in a south-westerly direction to the Borough Boundary.

Provided that these Byelaws shall not apply to any public gardens adjoining the Promenades which are governed by the Byelaws made by the Council with respect to Public Parks, Public Walks and Places of Public Resort or Recreation nor shall they apply to the Public Gardens lying to the south of the main carriageway of The King's Parade and bounded on the west by the Red Noses and on the east by the extension of Atherton Street.

2. Nothing in these Byelaws shall prejudice or affect the rights, powers and privileges of the Commissioners or be leaded to be a dedication by them of the Wallasey Embankment to the public as a highway.

Begging.

3. No person shall on the Promenades to the annoyance of obstruction of any person using the Promenades beg or olicit alms or for the purpose of selling or advertising any enticle or of obtaining custom, tout or importune, either exhally or by the distribution of handbills, circulars or divertisements. Provided that this byelaw shall not apply any collection of money or sale of any article in coordance with any Regulations made under Section 5 of the Police, Factories, &c. (Miscellaneous Provisions) Act, 1916, for the time being in force in the Borough.

Noisy Instruments.

4. No person shall ring any bell or sound any gong or dow any horn or trumpet or use any other musical or noisy

instrument or wantonly and continuously sing on the Promenades to the annoyance of any person using the Promenades.

Selling and Hawking.

5. Where any part of the Promenades has, by notices affixed in conspicuous positions on the Promenades, been set apart by the Council for the sale and hawking of such articles, commodities, or things, or classes thereof, as may be specified in the notices, no person shall offer for sale or hawk the same on any other part of the Promenades.

Beating Carpets, etc.

6. No person shall on the Promenades, to the annoyance or obstruction of any person using the Promenades, beat, shake, sweep, brush or cleanse any carpet, drugget, rug or mat, or any other fabric retaining dust or dirt.

Disorderly Behaviour.

7. No person shall make any violent outcry, noise or disturbance on the Promenades so as to disturb the peace.

Deposit of Materials, etc.

8. No person shall deposit any seaweed, stones, boulders, flints, marl, gravel, sand, soil, or material of any description on the Promenades, or the seats or shelters thereon (unless the same is to be used in the repair thereof or for the repair of any works for the protection of the Promenades or Foreshore).

Dogs Barking.

9. No person shall on the Promenades after being required to desist by any Constable or by any Officer of the Corporation incite any dog to bark to the annoyance of any person using the Promenades.

Throwing Missiles.

10. No person shall on the Promenades wantonly

discharge any firearm or throw or discharge any sto ... or other missile to the damage or danger of any person using the Promenades.

Bonfires.

11. No person shall make any Bonfire on the Promenades to the danger of persons using the Promenades.

Use of Conveniences, etc.

12. No male person above the age of eight years shall on the Promenades intrude on or use any place set apart for the use of females and no female person shall intrude on or use any place set apart for the use of male persons on the Promenades, and which are indicated by adequate notices a. or near to such places.

Damage to Flower Beds, etc.

13. No person other than a person employed by or on behalf of the Corporaton shall cut, uproot, or damage any tree, shrub or plant on the Promenades, or walk, run over or stand upon any flower bed, shrub, underwood, fern, or plant, or any ground which is prepared for their reception or growth.

Damage to Property.

14. No person shall wilfully mark, soil or deface any wall, fence, building, barrier, railing, seat, notice board or other structure or erection belonging to the Corporation or the Commissioners on the Promenades.

Litter.

15. No person shall place or deposit and leave on the Promenades any glass, china, earthenware, tin, carton, paper, or other refuse or litter so as to affect or tend to affect injuriously the public amenities of the Promenades.

Bill-posting.

16. No person other than a person employed by or on

behalf of the Corporation or the Commissioners shall affix or post any bill placard or notice to or upon any wall, fence. building, barrier, railing, fixed or movable seat, notice board, or any other structure or erection belonging to the Corporation or the Commissioners respectively on the Promenades.

Performances, etc.

- 17. Where any part of the Promenades has, by notices affixed in conspicuous positions on the Promenades, been set apart by the Council for the delivery of such lectures, sermons, speeches, or performances of music, or for the holding of such entertainments as may be indicated in the notices:-
 - (i) no person shall deliver any lecture, sermon, or speech, or perform any music, or hold any entertainment so indicated, as the case may be, on any other part of the Promenades;
 - (ii) no person shall use or attempt to use any such part in such manner as to interfere with or hinder any person already using it for any purpose for which it has been set apart.

Games.

18. No person shall on the Promenades to the danger, annoyance or obstruction of any other person play Cricket, Football, Golf or Hockey, or take part in any organised boxing, wrestling, racing, or jumping contest or in any organised game involving the exclusive use of a portion of the Promenades.

Booths, Tents, etc.

19. No person shall except in pursuance of any lawful authority in that behalf place, build or construct upon any part of the Promenades any booth, tent, bathing machine, shed, stand, stall, show, exhibition, swing, roundabout or · other like erection or thing.

Vehicles, etc.

20. No person shall lead, drive or ride any horse or

her beast of draught or burden or any vehicle, whether twn or propelled by animals, persons or any mechanical wer (other than bath or hand chairs and perambulators) any motor cycle, pedal cycle, tricycle or fairy cycle on or er the Promenades.

Provided that this Byelaw shall not apply:—

(a) to the following sections of the Promenades, namely:-

> Seacombe Vomenside—From Seacombe Ferry to Ferly View Road.

> Lower Promenade-From Egerton Street to New Brighton Ferry.

Marine Promenade and The King's Parade—From New Brighton Ferry to the Red Noses.

- (b) in any case where it is necessary to cross any of the Promenades to obtain access to the Shore by means of a Slipway provided for that purpose;
- (c) to any person engaged in the execution of work on or in connection with the Promenades for oron behalf of the Council or (as respects the Wallasey Embankment) the Commissioners;
- (d) to any person under the age of 14 years riding or driving a tricycle or fairy cycle otherwise than to the danger of any person using the Promenades.

Wilfully Obstructing Constables, etc. in execution of duty.

21. No person shall on any part of the Promenades Ifully obstruct, disturb or interrupt any Constable or licer of the Corporation or of the Commissioners in the oper discharge of his duties or any person employed by Corporation or by the Commissioners in the proper ecution of any work connected with the improvement, Jaintenance, or regulation of the Promenades.

Penalties.

22. Every person who shall offend against any of the foregoing Byelaws shall for every such offence be liable on summary conviction to a fine not exceeding £5.

Repeal of Previous Byelaws.

23. From and after the date on which the foregoing Byelaws come into operation the Byelaws made by the Wallasey Local Board under Section 79 of the Wallasey Local Board Act, 1890, on the 6th day of October, 1892, and allowed by the Local Government Board on the 18th day of November, 1892, shall be and are hereby repealed.

The above Byelaws were made by the Council of the Borough of Wallasey at a meeting held on the 4th day of April, 1935.

made on the 8th day of October, 1959 by the Mayor, Aldermen and Burgesses of the County Borough of Wallasey

with regard to the

PROMENADES

within the said Borough.

SUPPLEX TAL BYELAW

made by the Mayor, Aldermen and Burgesses of the County Borough of Wallasey acting by the Council under powers conferred by Section 83 of the Public Health Acts Amendment Act, 1907, with respect to the Promenades within the Borough.

Byelaw No. 20 (relating to the loading, driving or riding of animals or vehicles on or over the Promenades), of the series of byelaws made by the Council on the fourth day of April 1935 and confirmed by the Secretary of State on the twenty-second day of May 1935 as amended by the byelaws made by the Mayor, Aldermen and Burgesses of the County Borough of Wallasev acting by the Council on the second day of May 1940 and confirmed by the Secretary of State on the twenty-fifth day of June 1940 and as further amended by a byelaw made by the Mayor, Aldermen and Burgesses of the County Borough of Wallasev acting by the Council on the eighteenth day of April 1957 and confirmed by the Secretary of State on the thirteenth day of June 1957 is hereby repealed and the following byelaw shall be substituted therefor and shall be construed as one with the aforesaid series of byelaws :-

20. No person shall lead, drive or ride any horse or other beast of draught or burden or any vehicle, whether drawn or propelled by animals, persons or any mechanical power (other than bath or hand chairs and perambulators) or any motor cycle, pedal cycle, tricycle or fairy cycle on or over the Promenades.

Provided that this Byelaw shall not apply:—

- (a) in any case where it is necessary to cross any of the promenades to obtain access to the shore by means of a slipway provided for that purpose;
- (b) to any person ringaged in the execution of work on or in connection with the Promenades for or on behalf of the Council or (as respects the Wallasey Embankment) the Commissioners;
- (c) to any person under the age of 14 years riding or driving a tricycle or fairy cycle otherwise than to the danger of any person using the Promenades; or
- (d) to any person suffering from some physical defect or disability who is using an invalid carriage,



that is to say, a mechanically propelled vehicles the weight of which unladen does not exceed five hundred weight and which is specially designed and constructed, and not merely adapted, for the use of such a person so long as the said invalid carriage is being used on any of the following sections of the Promenades:-

- The "Seacombe Promenade" from its junction with "Sandon Promenade" to Ferry View Road:
- The "Sandon Promenade";
- (iii) The "Egremont Promenade";
- (iv) The "Magazines Promenade";
- (v) The "Tower Promenade" from its junction with the "Magazines Promenade" to Egerton Street; and is not being driven to the danger of any person using the Promenades.
- (e) to the following sections of the Promenades, namely:
 - A. The Seacombe Promenade—from Seacombe Ferry to Ferry View Road;
 - B. The Tower Promenade—from Egerton Street to New Brighton Ferry;
 - c. The Marine Promenade;
 - p. The King's Parade commencing at the termination of the Marine Promenade and extending thence in a westerly direction to its junction with the Sea Defence Works at a point 300 yards west of Harrison Drive;
 - E. The New Road to the north of and parallel with the Wirral Line Railway, New Brighton branch, extending in a westerly direction from the Red Noses at its junction with "The King's Parade" to a junction with "The King's Parade at its westerly termination at the Sea Defence Works.
 - F. The extension of Sea Road, between the Railway described in E and "The King's Parade", except that part constructed as footway only, from the railway extending 120 yards north;

- G. The extension of Sandchiffe Road between the railwayse-scribed in E and "The King's Parade".
- u. The extension of Harrison Drive between the railway described in E and "The King's Parade".

The Common Seal of the Mayor, Aldermen and Burgesses of the County Borough of Wallasey was hereunto affixed this eighth day of October, 1959.
